**PURPOSE**

The purpose of this modification is to exercise the renewal option on Contract 720C-04222-09R08 between Dept. of Behavioral Health and Developmental Services and VISTA Staffing Solutions, Inc. The above reference contract shall be renewed for one year beginning November 1, 2014 and expire October 31, 2015.

**PERIOD OF PERFORMANCE**

The Period of Performance is extended from November 1, 2014 through October 31, 2015. This is the fifth and final contract renewal. The renewal is in accordance with Item 6.7 "Renewal of Contract" of the original contract.


