

FOURTH AMENDMENT

This **FOURTH ADMENDMENT** to the General Health Care Services Agreement made November 1, 2003, as amended effective December 15, 2004, November 1, 2005, and November 1, 2006 by the **VIRGINIA DEPARTMENT OF MENTAL HEALTH, MENTAL RETARDATION AND SUBSTANCE ABUSE SERVICES ON BEHALF OF CATAWBA HOSPITAL (CATAWBA), CENTRAL VIRGINIA TRAINING CENTER (LYNCHBURG), COMMONWEALTH CENTER FOR CHILDREN & ADOLESCENTS (STAUNTON), NORTHERN VIRGINIA TRAINING CENTER (FAIRFAX), SOUTHERN VIRGINIA MENTAL HEALTH INSTITUTE (DANVILLE), SOUTHWESTERN VIRGINIA MENTAL HEALTH INSTITUTE (MARION), SOUTHWESTERN VIRGINIA TRAINING CENTER (HILLSVILLE), WESTERN STATE HOSPITAL (STAUNTON) AND PIEDMONT GERIATRIC HOSPITAL (BURKEVILLE)** (hereinafter referred to as "DMHMRSAS") and **THE RECTOR AND VISITORS OF THE UNIVERSITY OF VIRGINIA ON BEHALF OF ITS MEDICAL CENTER** (hereinafter referred to as the "Medical Center") and the **UNIVERSITY OF VIRGINIA HEALTH SERVICES FOUNDATION** (hereinafter referred to as "HSF"), (the Medical Center and HSF are hereinafter collectively referred to as "Contractors") (hereinafter "the Agreement") is made effective the 1st day of November 2007.

1. Under ATTACHMENT D "SCOPE OF SERVICES" a new item 6. shall be added as follows:

6. Effective February 1, 2008 DMHMRSAS shall provide digital copies of ECGs via electronic transmission.

2. Under ATTACHMENT D "REIMBURSEMENT" item 1. shall be deleted in its entirety and replaced with the following:

1. HSF shall be paid by DMHMRSAS ONE THOUSAND THREE HUNDRED AND SEVENTY NINE DOLLARS AND NO CENTS (\$1,379.00) per month for EKG overreads provided for DMHMRSAS's Commonwealth Center.

This Agreement shall be renewed for an additional one (1) year, to commence November 1, 2007 and ending October 31, 2008.

Except as otherwise provided herein, all other terms and conditions of the Agreement November 1, 2003, as amended effective December 15, 2004, November 1, 2005, and November 1, 2006 remain unchanged and in full force and effect,
