**Program Reports:**

T. Neumann; T W Neumann & Associates; which has about 150 clients has had no incidents or allegations to report during the past quarter and there have been no significant changes in their present programs.  
Kelly Evans, The UP Center. Their (In-Home Services, Sponsored Placement- Adults, Sponsored Placement- Children (Temp) had an allegation which was unfounded there have been no significant changes in their present programs. They have 9 new homes for which they are seeking temporary affiliation.  
Corey Brooks; Community Solutions; reports no incidents or allegations during the past quarter and there have been no significant changes in their present programs. They are seeking temporary affiliation for two new programs  
Betty Gray-Henson; Alternative Family Treatment Services, Inc, has received its license; they report no incidents or allegations to report during the past quarter and there have been no significant changes in their present programs.  
Rizal Cruz; AJ&T Ind. Group Home; which has about 14 clients has no incidents or allegations to report there have been no significant changes in their present programs.  
Myrna M. Gonzalez; Prosperity Homes, LLC; reports: no incidents or allegations during the past quarter and there have been no significant changes in their present program.  
Gregory Ash; Restorer of Broken Walls; reports no incidents or allegations this past quarter and no program changes.
