The meeting was called to order. The committee went into Executive Session. The normally scheduled programs were reviewed. Physical management plans for 00526 were reviewed.

The committee went into Open Session. A motion was made to approve the minutes of the May meeting. It was seconded and all voted in favor. A motion was made to approve the programs reviewed at the current meeting. It was seconded and all voted in favor.

A copy of the new Departmental Instruction 214 (RTS)11, Use of Seclusion and Restraint in State Facilities was distributed among the committee members. Mr. Davis noted that he was working on revising the current SEVTC Instruction 2243 to reflect these changes. The committee would receive a copy when it is finished.

Mr. Prost discussed that his office has hired another advocate. He also distributed the Provider Quarterly Report of Human Rights Activities and the Provider Annual Report of Human Rights Activities designed by the Human Rights office to be used by all affiliate to report to the LHRC. He also reminded the committee of the Rights Hearing scheduled for June 28, 2011. Members will receive training at 8:30 and the hearing is scheduled to begin at 9:00.

Representative from four new affiliates attended seeking representation by this LHRC for their programs.

Leonilo O. Gloria, of Casa de Gloria presented his information to the committee. After discussion with him a motion was made to approve his affiliation and accept his behavior management plans and program rules. It was seconded and approved by all.

Verna Hyman of Terry's Place presented information to the committee. After discussion with her a motion was made to approve her affiliation and accept her behavior management plans and program rules. It was seconded and approved by all.

Shawn Minter and Demetrius Whitehurst of Vigilant Mindz presented information for both the in-school and in-home programs for children. They are currently based in Richmond but are expanding their program to this area. This committee would only serve for the local program. After discussion with them a motion was made to approve their affiliation and accept their behavior management plans and program rules. It was seconded and approved by all.

Kwame Edusei of Achievers Counseling Services presented information to the committee. After discussion with him a motion was made to approve his affiliation and accept his behavior management plans and program rules. It was seconded and approved by all.

All affiliates were told that they would receive, by email, a welcome letter, the quarterly and annual report forms and the Cooperative Agreement. The signed Cooperative Agreement may be returned when they make their semi-annual visit in October. The first eight affiliate will have October/ April as their presentation months. Future requests for affiliation will attend on a January/July rotation.

Mr. Moore told the committee he had received three other requests for affiliation with the LHRC. He will invite them to the July 20 meeting as their introductory meeting.

The next meeting will be held on **July 20, 2011** at 8:00 am in the Staff Training conference room. The hearing is scheduled for June 28 and the committee will meet in Staff Training area.
